The inflating valves shown in broken lines in some of the figures are to show environment and are not part of the claimed design.

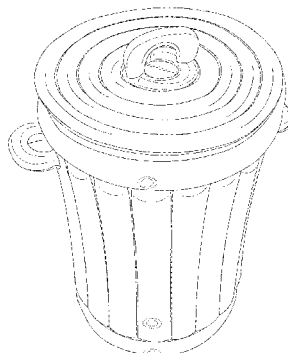

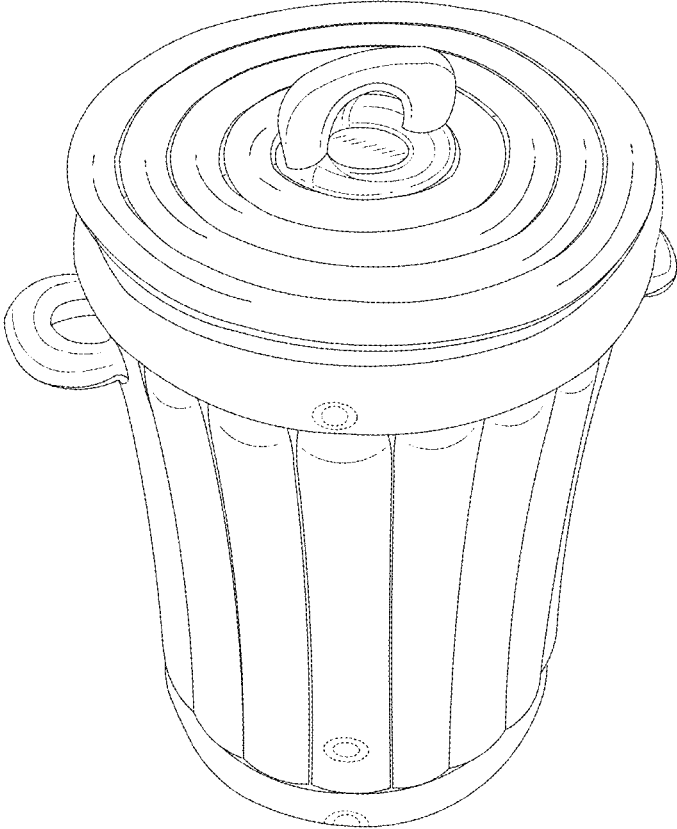

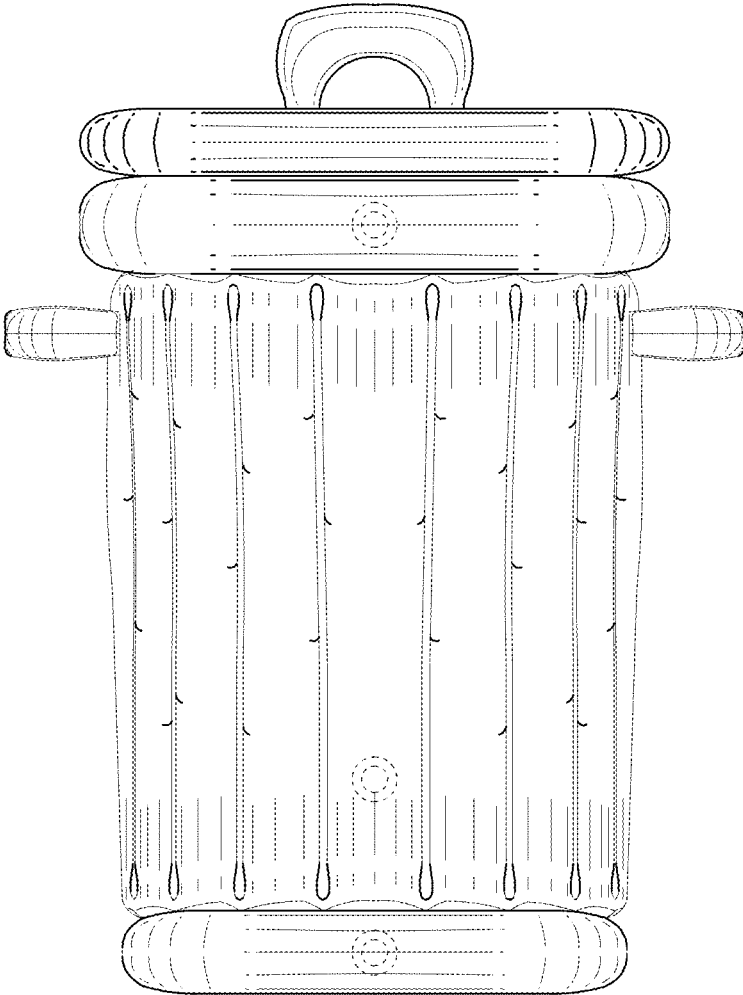

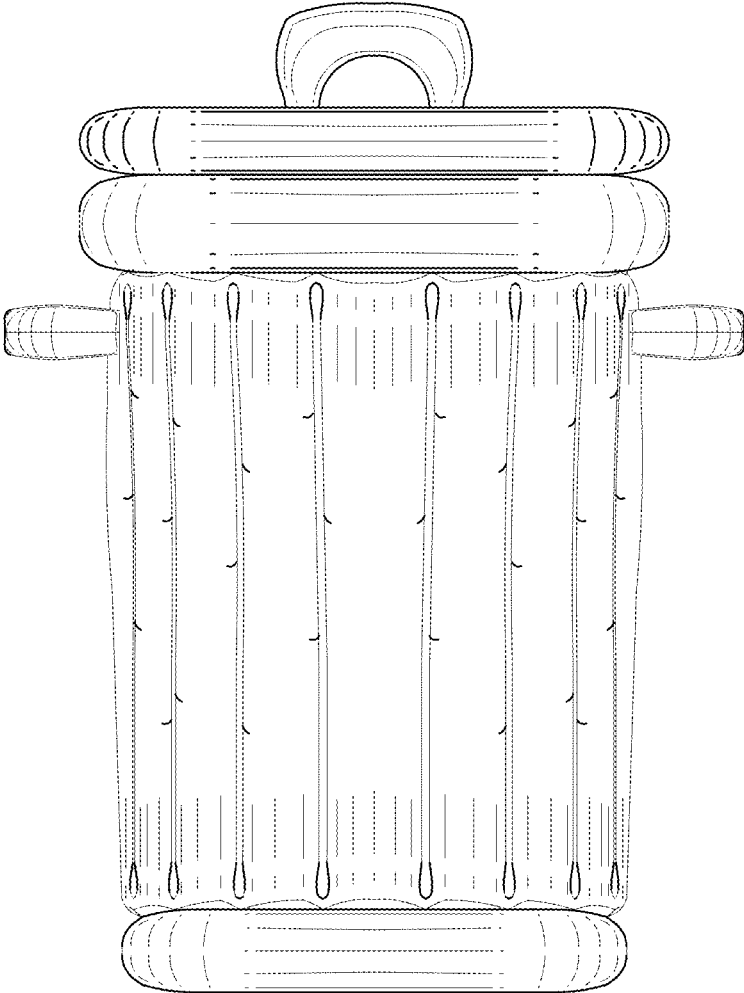

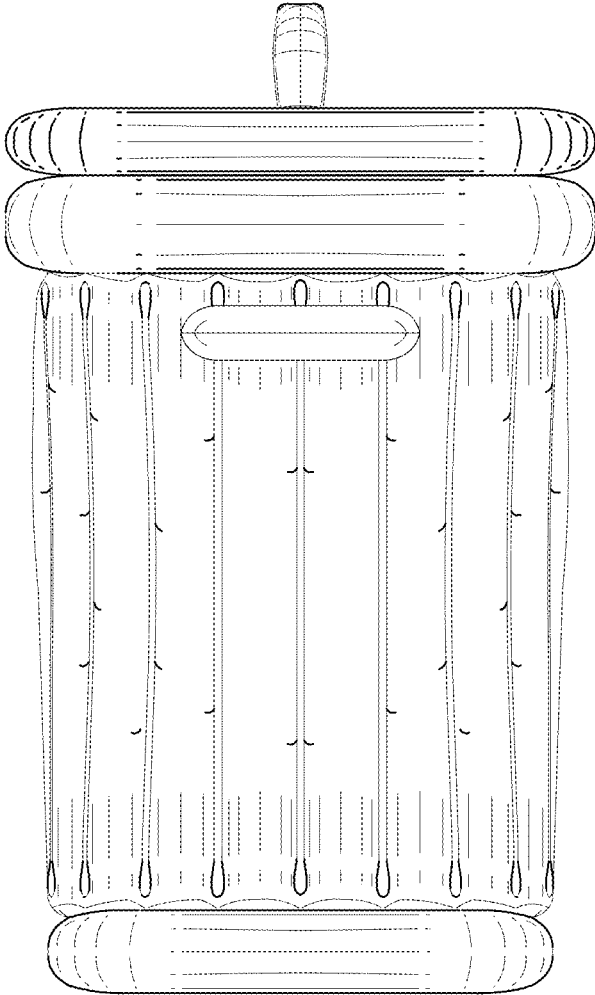

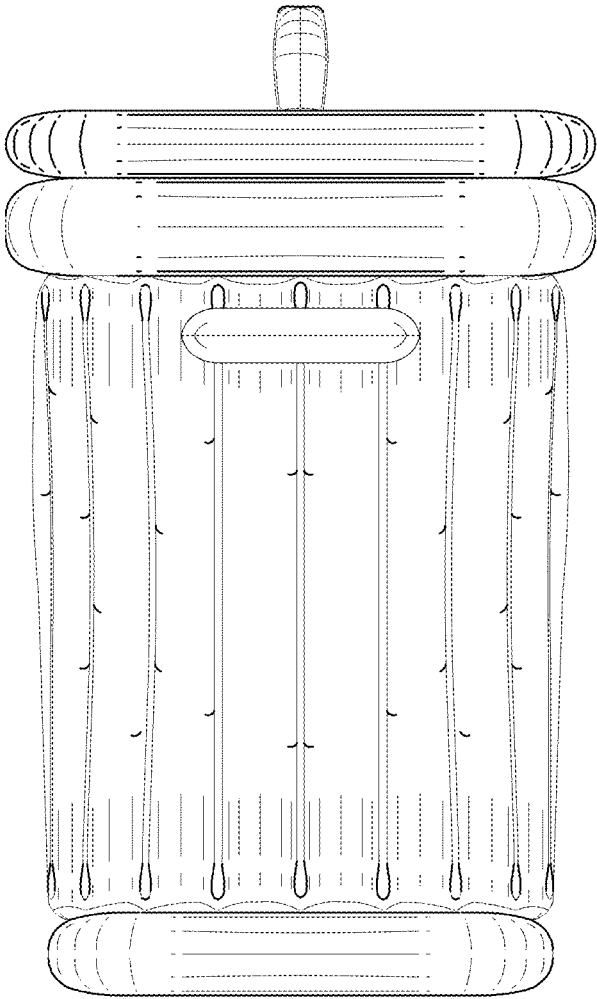

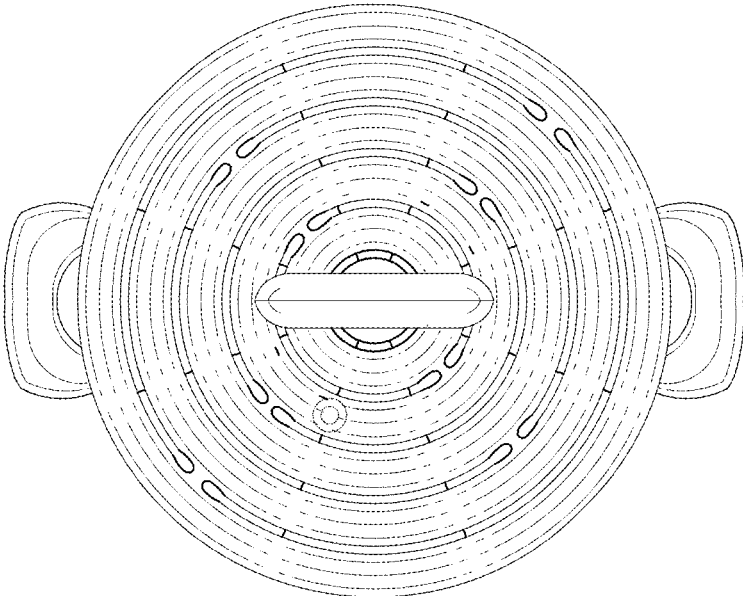

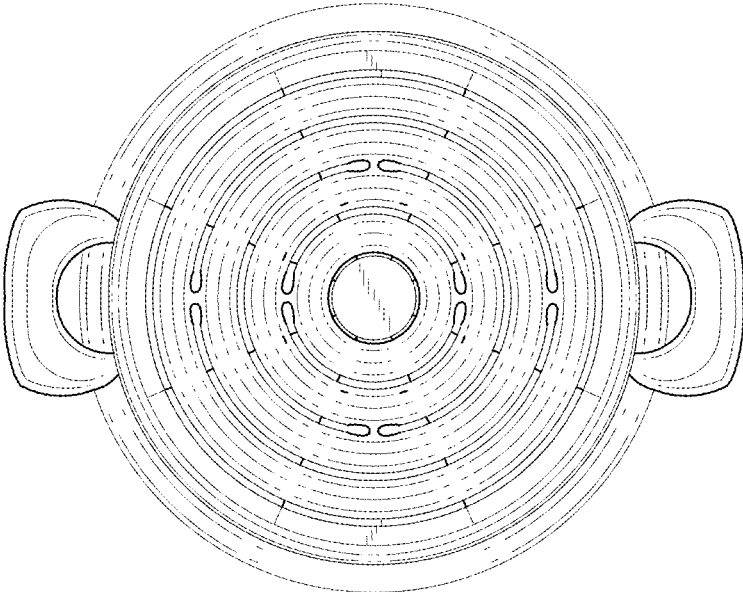

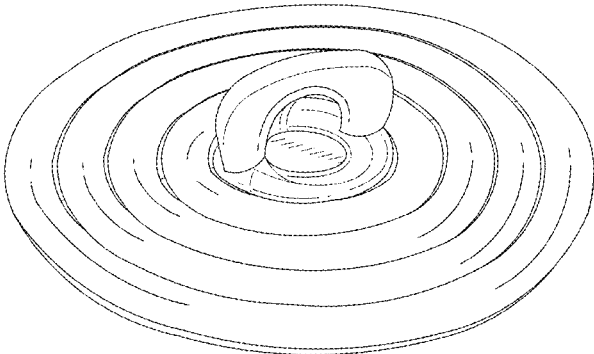

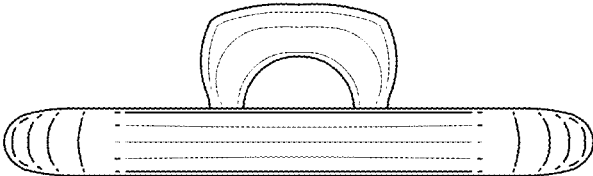

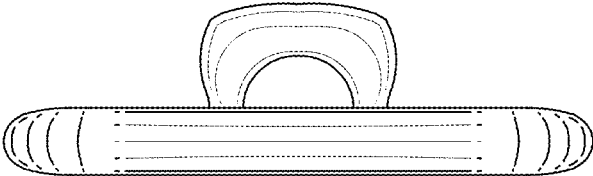

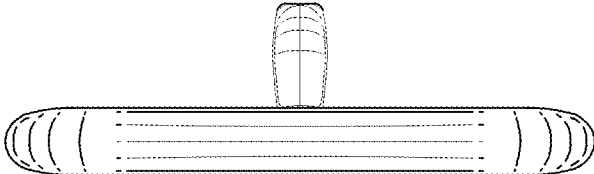

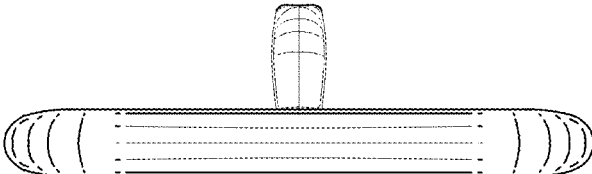

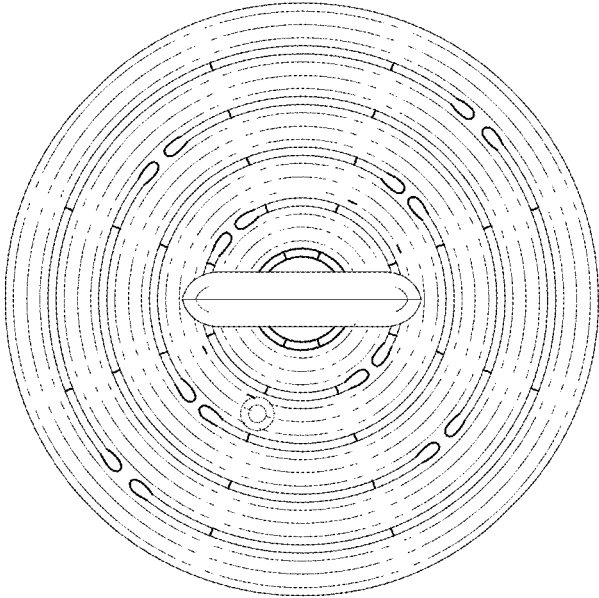

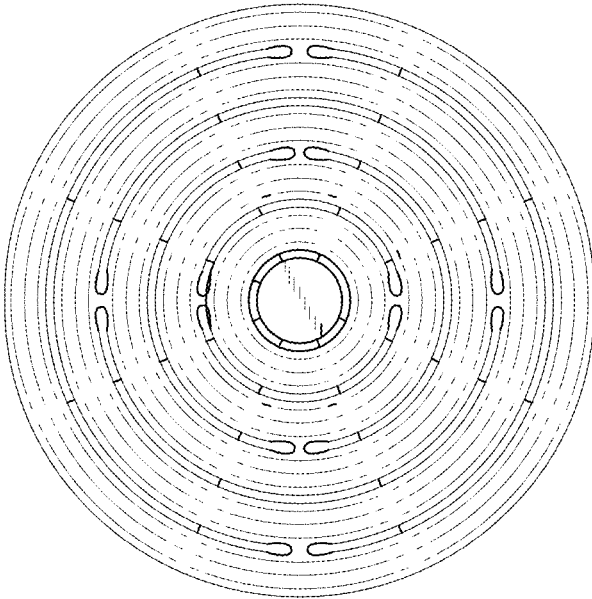

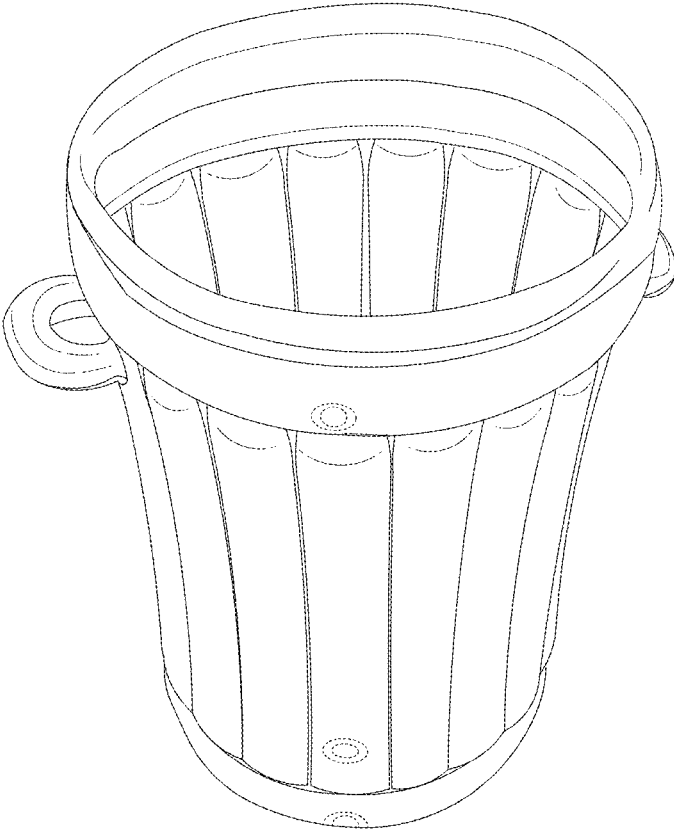

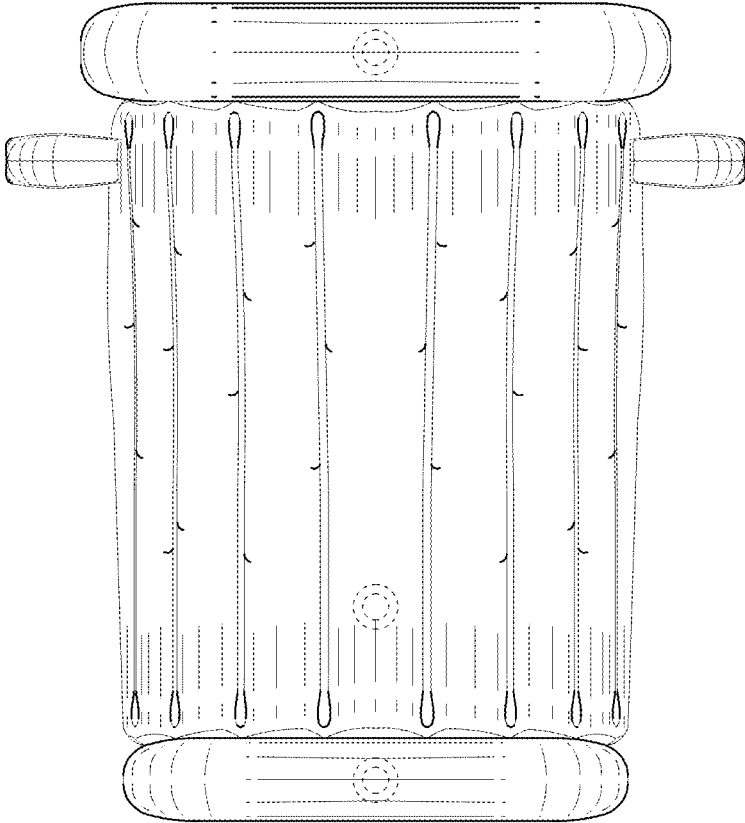

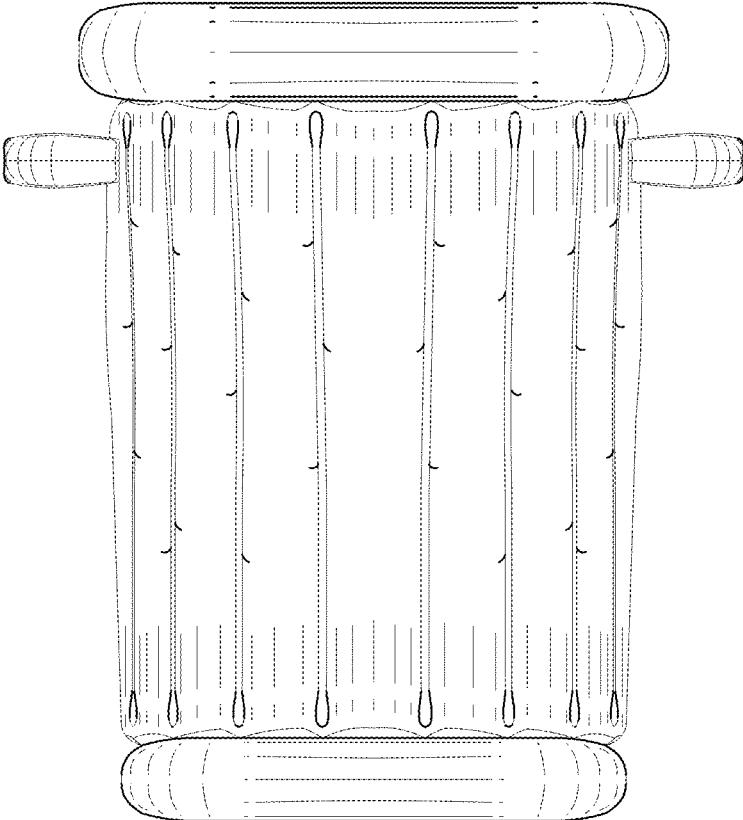

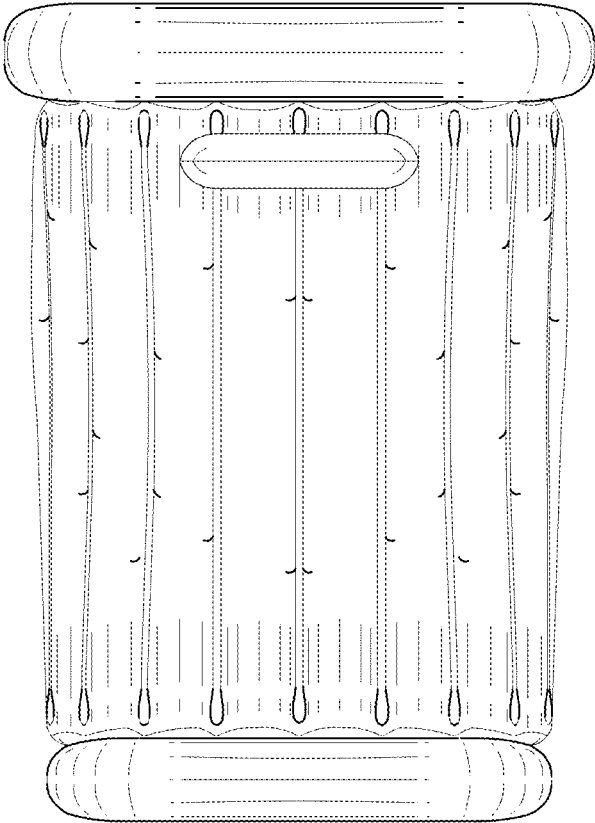

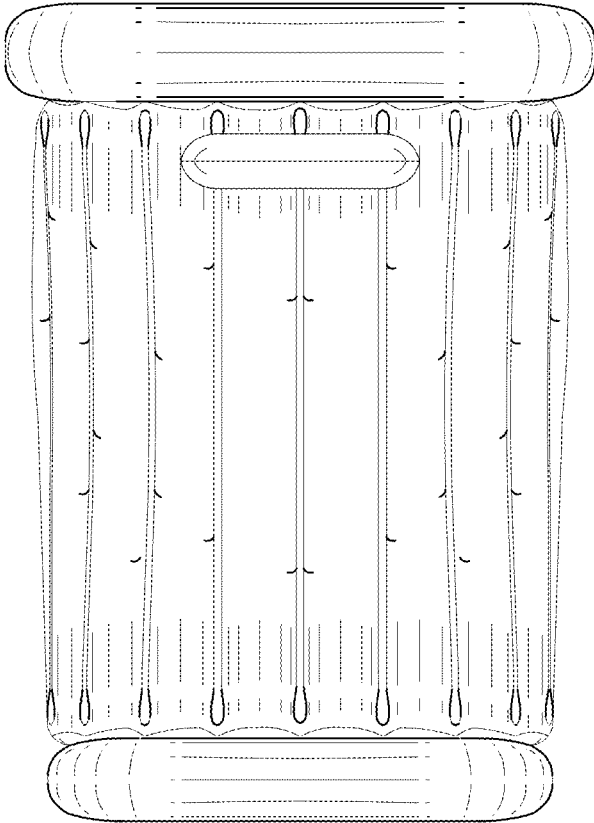

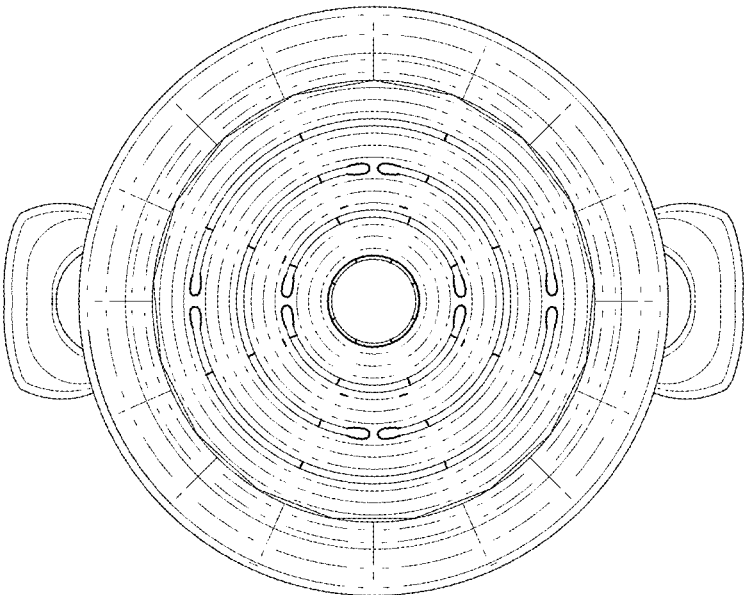

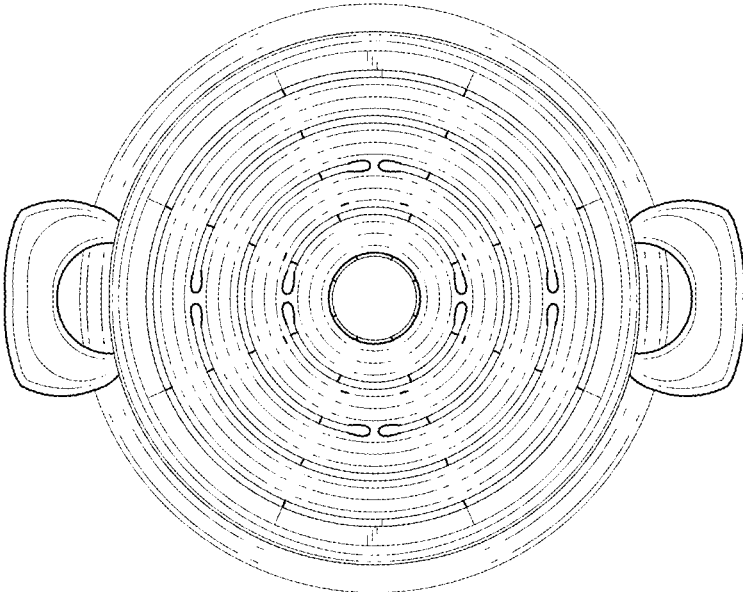
